

# Information obligation for personal data processing

## CONTACT FORM

### **Purposes of personal data processing:**

Personal data provided via the [WRITE TO US](#) contact form located on the website [www.debongre.sk](http://www.debongre.sk) is processed by the operator on the basis of legitimate interest and for the purpose of providing a response to questions or possible suggestions to the person concerned.

### **Category of affected persons:**

- persons who contacted the Operator via the contact form,
- customer contact person,
- an employee of the customer.

**Category of personal data:** ordinary personal data.

**List of personal data:** name, surname, e-mail, text of the sent message (content of the request), content attachments, other voluntarily provided optional personal data.

**Legality of personal data processing:** Art. 6 par. 1 letter f) of the general regulation on data protection - legitimate interest in providing a response to questions or potential suggestions to the person concerned.

**Legal obligation to process personal data:** personal data is not processed on the basis of a special legal regulation.

### **Recipients or categories of recipients to whom personal data will be provided:**

web hosting provider, email communication platform provider, data service provider.

- **to third countries:** personal data are not provided to third countries,

- **to international organizations:** personal data is not provided to international organizations.

**Other authorized entity:** public authorities. However, public authorities that may receive personal data as part of a specific inquiry in accordance with Union law or the law of a Member State are not considered recipients; the processing of said data by said public authorities is carried out in accordance with applicable data protection rules, depending on the purposes of processing. Personal data to the extent requested from an authorized entity (e.g. the police as part of an investigation of misdemeanors or crimes).

**Disclosure of personal information:** personal information is not disclosed.

**Legitimate interest of the Operator:** processing of personal data for the purpose of the legitimate interests of the Operator is carried out. The legitimate interest of the Operator is to contact people back based on the data entered in the form and to provide a response to questions or possible suggestions to the person concerned.

**Period of storage of personal data:** for the period necessary to fulfill the purpose of processing - i.e. j. providing a response to questions or potential suggestions to the person concerned, but for a maximum period of 1 year.

**The operator guarantees** that the personal data provided by the affected person will be processed in accordance with the principle of minimization of storage, and in the event that the purpose of processing ceases to exist, the operator guarantees to delete the personal data.

In the event that said personal data will be processed for a purpose other than that specified above in this information obligation, the person concerned will be informed about this purpose as well as about the legal basis of such processing even before such processing.

## **Information obligation for personal data processing**

**Technical and organizational security measures:** organizational and technical measures for the protection of personal data are elaborated in the operator's internal regulations. Security measures are implemented in the areas of physical and object security, information security, encryption protection of information, personnel, administrative security and protection of sensitive information, with precisely defined powers and duties specified in the security policy.

**Automated individual decision-making including profiling:** automated individual decision-making including profiling is not performed.
